Purpose

Methodology

This is the 2014 edition of the St. Lucie County Detention Center Annual Population Report. The report contains statistics for the year 2013 with some analysis dating back to 1995.

Most of the data for the statistics come from 3 sources.

- 1: Daily population report
- 2: Data entered into the Sheriff's Office computer jail inmate tracking system
- 3: Data extracts from St. Lucie County Circuit Court database

For the jail population, all of the statistics presented here are based on actual counts rather than on sampling, thus eliminating sampling errors.


A **booking** is the admission of a new inmate into the jail. If an inmate is fully released and then comes back to jail, that counts as a new booking. Hence when the number of bookings is given for a year, the same inmate will be counted as many times as he/she is booked. An inmate may similarly be **released** several times in a given period.

A daily population count records every inmate in jail exactly once at the time of the count. An inmate count is conducted every day at midnight and it is used as the official figure for the number of inmates in jail on the preceding day.


Two conventions employed in this report involving inmates with multiple charges should be noted. One is that, when citing statistics about inmate charges, the most serious charge is used. The other is that inmates with multiple charges are counted as sentenced if, and only if, they are sentenced on every charge.


Yearly Average Daily Population Summary - Excluding Federal Inmates



Average Daily Population - Charge Status




Average Daily Population - Offense Type - Includes Federal Inmates









Top 10 Charge Offenses


Top 10 Arrest Charges









Average Length of Stay All Inmates






Average Sentenced Inmate Count







Inmates Housed Over 365 Days - Average Yearly Summary




Inmates by Charge Status






Inmates by Offense Type









Cases in this category date from 1974 to 2008. They are comprised of a large backlog of closed cases that remain open due to docketing issues , outstanding fees, or cases with outstanding warrants.




The clearance rate is a measure of the number of cases filed as a percentage of the number of cases disposed of for the year. A number exceeding 100% indicates the number of dispositions exceeds new case filings for the reporting period.




The 180 day rule clearance rate is a measure of the number of cases disposed of within 180 days from their entry date. In January for example, 47% of the cases filed were disposed of within 180 days.

The 2013 clearance rate is a measure of the number of cases filed as a percentage of the number of cases disposed of for the year. A number exceeding 100% indicates the number of dispositions exceeds new case filings for the reporting period.

Clearance Rate Measure



The 2013 180 day rule clearance rate is a measure of the number of cases disposed of within 180 days from their entry date. In January for example, 33% of the cases filed were disposed of within 180 days.
